I further give ACGW, or anyone authorized by ACGW, the absolute right and permission, to use, re-use, edit, publish and republish photographic portraits, pictures or video of me, or in which I may be included in whole or in part, or composite or distorted in character, or form, in brochures and other materials which promote, publicize, advertise, and otherwise exploit the Event (collectively, the "Materials") in perpetuity. The validity, construction, and all other matters related to this agreement, shall be interpreted and governed by the laws of the State of Florida. If any court of competent jurisdiction finds any provision of this agreement to be unenforceable or invalid, then such provision shall be ineffective to the extent of the court's finding without affecting the enforceability or validity of this agreement's remaining provisions.
